Subject : Implementation of New Operational Structure
for Sugar Trade on eBuySugar.com

Attention of Registered Users is drawn that w.e.f. April 06, 2022 a new operational structure for sugar trade will be implemented. The new structure for trading on eBuySugar will be as following :

Buyer & Seller (hereinafter referred to as “Users”) shall be registered members of www.ebuysugar.com for sugar commodity having necessary licenses of trading and statutory approvals for purchase and sell of sugar commodity for domestic and international markets as per prerequisites for trading and will be allowed to participate in the e-trade of sugar commodity to be conducted by the seller or the buyer through the portal of www.ebuysugar.com or Mobile Apps.

JK Sugars & Commodities Pvt. Ltd. shall be counterparty to the trades of the User. (Illustration: Where a user is a buyer then eBuySugar shall be the Seller and where a user is a seller then eBuy Sugar shall be the Buyer to the said transactions). Where the e-trade goes through successfully and the transaction is confirmed the same shall be communicated by e-mail as well as notified on the eBuy Sugar website & Mobile Apps to the User. JK Sugars & Commodities Pvt. Ltd. shall remain to be the counterparty for payments and delivery processes.

Therefore, according to the new structure JK Sugars & Commodities Pvt. Ltd. shall be counterparty to the trades of the User right from buying or selling to payments and deliveries and the transactions shall be on Principal to Principal basis.

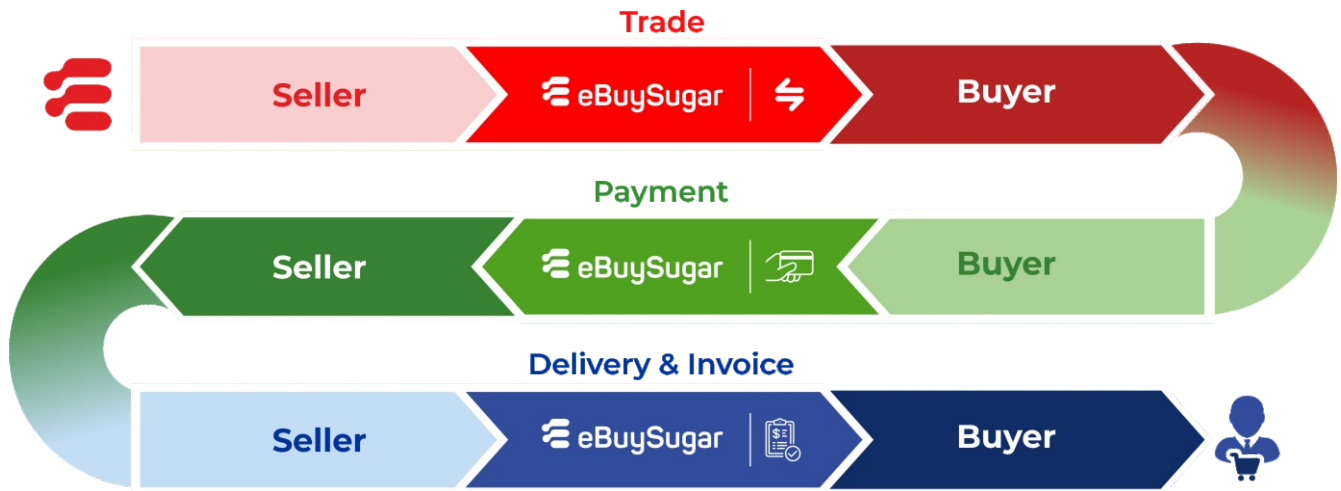
